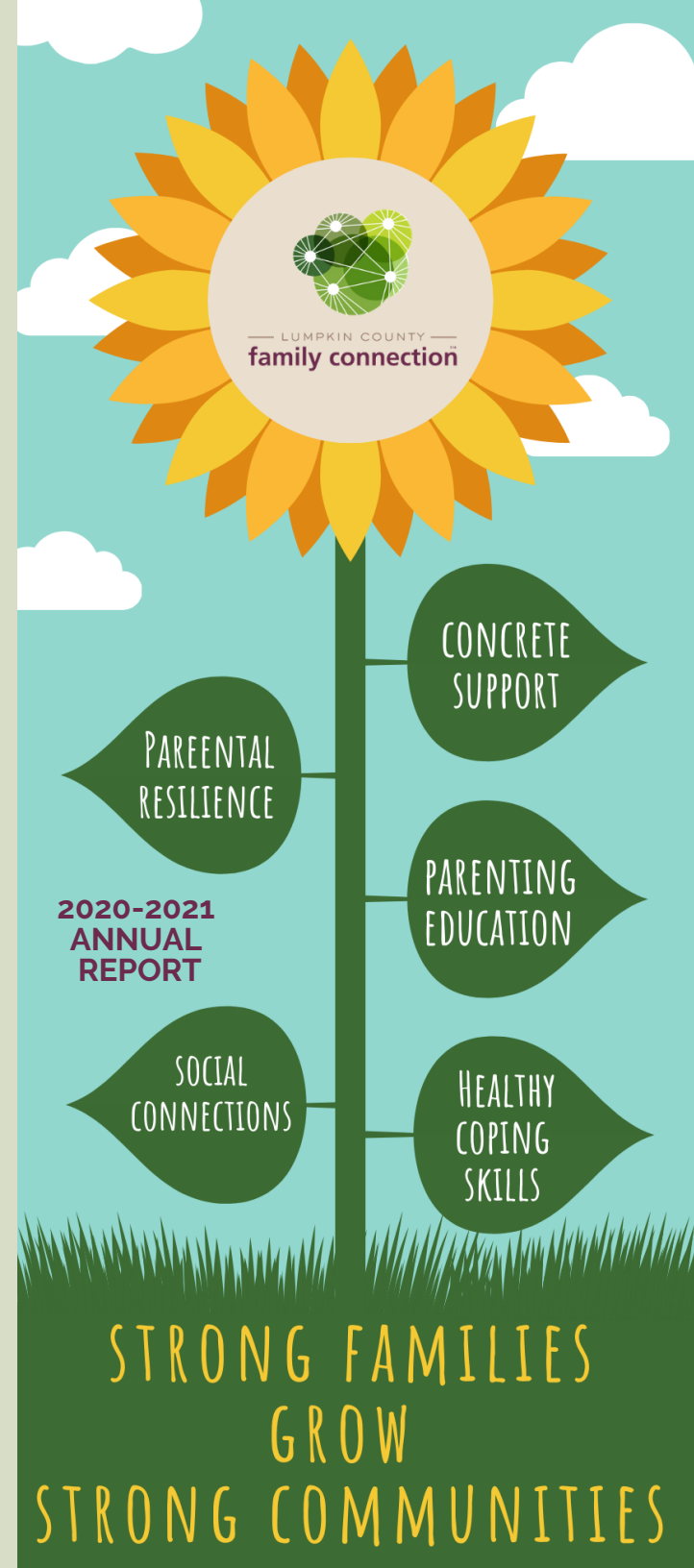

This guide helps show the different pathways through which families can receive services at the center.

GENERAL SERVICES PATH

Individuals receive referrals and brief assistance from the center.

Individuals on this path might receive:

- Phone/walk-in information/referrals to another organization
- Non-cash assistance (clothing, food, hygiene items, school supplies)
- Data Tracking: Staff tally the number of individuals who receive general services.

CENTER SERVICES PATH

Individuals participate in programs and services at the center.

Individuals on this path might:

- Participate in parenting groups, support groups, or trainings.
- Receive financial emergency assistance.
- Participate in the weekly Backpack Buddies Program.
- Data Tracking: Demographic and screening questions, program attendance, and resource referrals.

FAMILY DEVELOPMENT PATH

Families actively work with a family advocate using assessments to track family progress towards their goals.

Families on this path:

- Receive family development work, individual parenting education, individual life skill education, and coordinated case management.
- Might participate in other General or Center services as well.
- Data tracking: Required strength based assessment and parenting assessments. Referrals, services, and goal progress tracked.

Our Success Stories

Backpack Buddies Program:

- Provided over 46,000 pounds of food to children.

Mentor Program:

- Mentors provided 384 hours of mentoring to students

Collaborative Meetings:

- Built and maintained a community network to assist families in finding and accessing resources on the first Thursday @ noon

Family Advocacy Program:

- 4 Family Advocates provided case management for 76 families with 173 children
- 345 hours of Life Skills Education
- 60 hours of Support Groups
- 48 hours of Enrichment Activities
- 620 hours of Individual Parenting Education

Student Outreach Center:

- 107 families provided \$20,400 in Emergency Assistance
- 526 children provided clothing
- 127 children provided shoes
- 470 children provided school supplies
- 109 families provided hygiene items
- Christmas for over 450 children
